

SUMMARY ANNUAL REPORT FOR RAYTHEON RETIREE HEALTH BENEFITS PLAN

This is a summary of the annual report of the Raytheon Retiree Health Benefits Plan, (Employer Identification Number 95-1778500, Plan Number 565), for the plan year 01/01/2022 through 12/31/2022. The annual report has been filed with the Employee Benefits Security Administration, as required under the Employee Retirement Income Security Act of 1974 (ERISA).

Raytheon Company has committed itself to pay certain health and all dental claims incurred under the terms of the plan.

Insurance Information

The plan has insurance contracts with Kaiser Foundation Health Plan Inc., Kaiser Foundation Health Plan of Colorado, Kaiser Foundation Health Plan of The Mid-Atlantic and United Healthcare Insurance Company to pay certain health claims incurred under the terms of the plan. The total premiums paid for the plan year ending 12/31/2022 were \$30,562,019.

Because they are so called "experience-rated" contracts, the premium costs are affected by, among other things, the number and size of claims. Of the total insurance premiums paid for the plan year ending 12/31/2022, the premiums paid under such "experience-rated" contracts were \$159,322 and the total of all benefit claims paid under these experience-rated contracts during the plan year was \$48,562.

Basic Financial Statement

The value of plan assets, after subtracting liabilities of the plan, was \$182,897,840 as of the end of plan year, compared to \$220,797,700 as of the beginning of the plan year. During the plan year the plan experienced a change in its net assets of (\$37,899,860). This change includes unrealized appreciation and depreciation in the value of plan assets; that is, the difference between the value of the plan's assets at the end of the year and the value of the assets at the beginning of the year or the cost of assets acquired during the year. During the plan year, the plan had total income of \$35,779,296 including employer contributions of \$27,952,939, employee contributions of \$42,654,316, and earnings from investments of (\$34,827,959). Plan expenses were \$73,679,156. These expenses included \$2,663,053 in administrative expenses, \$71,016,103 in benefits paid to participants and beneficiaries.
