

SUMMARY ANNUAL REPORT FOR HUNTINGTON INGALLS INDUSTRIES HEALTH PLAN

This is a summary of the annual report of the Huntington Ingalls Industries Health Plan (Employer Identification Number 90-0607005, Plan Number 501) for the plan year 01/01/2021 through 12/31/2021. The annual report has been filed with the Employee Benefits Security Administration, as required under the Employee Retirement Income Security Act of 1974 (ERISA).

Huntington Ingalls Industries, Inc. has committed itself to pay certain claims incurred under the terms of the plan.

Insurance Information

The plan has insurance contracts with Aetna Life Insurance Company, CIGNA Health and Life Insurance Company, Delta Dental of Virginia, Hawaii Medical Service Association, Kaiser Foundation Health Plan Inc, Kaiser Foundation Health Plan of the Mid-Atlantic, MetLife Legal Plans, Metropolitan Life Insurance Company, National Union Fire Insurance Company of Pittsburgh, PA, Provident Life and Accident Insurance Company, Prudential Insurance Company of America, SIMNSA, Unum Life Insurance Company of America, and Vision Service Plan to pay certain claims incurred under the terms of the plan. The total premiums paid for the plan year ending 12/31/2021 were \$24,089,296.

Because they are so called "experience-rated" contracts, the premium costs are affected by, among other things, the number and size of claims. Of the total insurance premiums paid for the plan year ending 12/31/2021, the premiums paid under such "experience-rated" contracts were \$6,127,306 and the total of all benefit claims paid under these experience-rated contracts during the plan year was \$4,924,708.
